Although HERRERO and CARBONELL were in frequent contact during 1963 and HERRERO had visited CARBONELL's residence on one or two occasions, he knew little or nothing about CARBONELL's personal life or his associates. CARBONELL was considered to be a "loner" and was somewhat secretive about his movements, usually coming and going without warning.

Other than his friendship with PRUDENCIO ^{Duenas} DUEÑAS and his wife HILDA and his acquaintance with HERRERO and ALONSO, all of whom were sincerely anti-CASTRO, HERRERO did not know any of CARBONELL's friends. He had never heard CARBONELL mention anyone by the name of PACO. HERRERO had never noted that CARBONELL had made any particular effort to try to develop specific information concerning the activities or plans of the anti-CASTRO activists in Miami. ^{Cuba}

CARBONELL was generally considered to be a reputable individual and HERRERO had never noticed anything that would suggest that CARBONELL was involved in subversive activities against the United States or in behalf of the Cuban Government. In retrospect, HERRERO realized that CARBONELL had apparently used his contacts with HERRERO and his colleagues to obtain information about their activities.

HERRERO stated he had not seen or heard from CARBONELL since the Summer of 1964 when HERRERO had visited Miami from Puerto Rico. It was about that time that HERRERO had contacted CARBONELL's residence and learned that he was in New York City.

HERRERO stated that he is a permanent resident of the United States and considers this to be his second country. He indicated that if he ever obtained any additional information concerning CARBONELL or his activities, he would immediately contact United States Government authorities.
