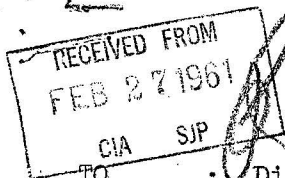

1. Your attention is invited to your Memorandum dated 18 January 1961, Subject Manuel Antonio VARONA - Internal Security - Cuba, File No. 105-76826.

2. Inquiries concerning financial contributions to VARONA and the Frente Revolucionario Democratico (FRD) by the CELLINI Family, and/or other U. S. gambling interests, are presently being made by this Agency. However, we have not yet been able to ascertain to what degree, if any, the allegations are true. Additional information is expected shortly.

3. The following information has come to our attention regarding this case:

a. According to an usually reliable source, Dino V. CELLINI worked at the casinos Tropicana and Rivera in Cuba before going to Haiti.

b. Dino V. CELLINI is presently residing at 12459 Key Stone Road, North Miami; telephone, PL 7-5834.

4. This Agency would appreciate any additional information the Bureau can provide on the Bernard NUCILLI mentioned in the Bureau report originating with the New York Office on 18 June 1957, [Subject - Rouhi JAMIL, File No. 105-24466 (SM)].
