On 9/25/62, [WF 1376-S] advised that he had learned [GONZALO] FACIO, Costa Rican Ambassador to the United States, had, on that date, contacted JOSE MIRO CARDONA, President of the Cuban Revolutionary Council at the Annapolis Hotel, Washington, D.C. [FACIO] and MIRO CARDONA discussed briefly a TV tape made by [FACIO] to be released on 9/30/62, in which [FACIO] advocates massive open aid to the Cuban exiles. MIRO CARDONA thanked [FACIO] for his effort in this regard.

The two then discussed Panama's plan for a Central American alliance against FIDEL CASTRO. MIRO CARDONA indicated he was aware of Panama's plan and likes it, but is of the opinion it lacks enforcement ability. [FACIO] feels there should be some reaction on the part of the Caribbean countries, and CARDONA said that there is no doubt that those countries are in danger and have a solid position for some action.

[FACIO] then spoke to TONY VARONA apparently MANUEL ANTONIO DE VARONA. [FACIO] and VARONA greeted each other as old friends and [FACIO] then told him about his contemplated TV appearance via tape and how he made the point that all liberating forces in Latin America received outside aid including CASTRO. VARONA then recalled the aid given in Costa Rica and Venezuela and both agreed that aid to the Cuban exiles is necessary. In commenting on the coming Foreign Minister's Conference, [FACIO] indicated that he felt the conference will result in nothing. VARONA commented, in regard to Cuba, that the problem the United States has is that several countries believe that Cuba is a problem involving Cuba, Russia, and the United States only. [FACIO] agreed and said that all countries in Central America are threatened as are all countries in Latin America.
