MANUEL ANTONIO VARONA
INTERNAL SECURITY - CUBA

On March 8, 1965, NK T-1, who has furnished reliable information in the past, and who has been closely associated with Varona in Cuba and recently in the United States, furnished the following information: (S)(u)

Dr. Manuel Antonio Varona, who was formerly associated with the Cuban Revolutionary Council, continues to reside in New York, but has talked of possibly moving to New Jersey. He continues his part time employment as an automobile salesman at the Carey Chevrolet Company at Union City, New Jersey, during the evenings. Varona only makes about \$80 to \$125 monthly from this job, being on a strict commission basis, and he is going to quit this job soon. Varona continues to work as a correspondent for "Diario de las Americas", a newspaper published at Miami, Florida. (u)

Varona is accused by many local Cubans of still being on United States Government payroll and to be a partner at Carey Chevrolet. These Cubans also accuse him of being independently wealthy from money he took out of Cuba. (u)

NK T-1 stated that Varona, in reality, is in a very poor financial condition, and is forced to live very frugally. (u)
