[redacted] whose identity is known to the Bureau.

The letterhead memorandum is classified "confidential" since it contains information from the above source, which might reasonably result in identification of an informant of continuing value and impair his future effectiveness.

Copies are being furnished to San Juan, Puerto Rico, inasmuch as it is indicated that SALVADOR DELGADO indicates he was going to Puerto Rico and there was an indication that the anti-CASTRO forces have over a thousand Puerto Ricans in Guatemala.
