CONCERNING THE MICROPHONE INSTALLATION AT SF 8677 PC'S APARTMENT, SAN FRANCISCO WILL MONITOR ONLY CONVERSATIONS TO WHICH SF 8677 PC IS A PARTY AND WILL NOT MONITOR CONVERSATIONS WHICH SOURCE CAN ONLY OVERHEAR.

THE CONSENT FURNISHED BY SF 8677 PC COVERS ONLY CONVERSATIONS TO WHICH SOURCE IS A PARTY, AND FURTHER THESE ARE THE ONLY CONVERSATIONS TO WHICH THIS INDIVIDUAL CAN CONSENT TO A MONITORING.

SAN FRANCISCO WILL FURNISH THE BUREAU WITH A SUMMARY OF CONVERSATIONS MONITORED ON A WEEKLY BASIS.

NOTE: SF 8677 PC is associating regularly with LCN figures in the San Francisco area. These individuals frequent the source's apartment in San Francisco and Attorney General approval has been obtained for a consensual microphone to be placed in the source's apartment. San Francisco advised that they intend to intercept and record any conversations to which the source is a party or which she can overhear.
