This is to confirm referenced Bureau telephone call granting authority for the use of body recording devices on the person of a confidential source.

Enclosed memorandum reflects approval of Deputy Assistant Attorney General Keeney in connection with the use of body recording devices for a period of 30 days for the purpose of recording conversations the source may have with individuals who may be involved in this case.

Following expiration of the 30-day period authorized, or when recording devices are no longer required, Bureau is to be promptly advised by letter the following information relative to the use or non-use of the body recorder:
