PROGRESS LETTER

This case was instituted by the San Francisco Division as San Francisco had an informant, SF8677PC, employed as a waitress at Sal's Espresso Cafe, 287 Ellis Street, San Francisco, California. Sal's Espresso Cafe was known to the San Francisco FBI Office as a meeting place and message center for well known West Coast LCN figure ALADENA T. FRATIANNO.

SF8677PC had an apartment located in the Mission District of San Francisco, California, and gave her consent for electronic surveillance to be instituted at her apartment. Valuable general intelligence and travel information was furnished by the PC, and through the use of electronic surveillance; however, no specific criminal violations were obtained in regard to the activities of JIMMY FRATIANNO and other known West Coast LCN figures. In view of the above, electronic surveillance was terminated after approximately 2 months, and SF8677PC was closed as she had become very apprehensive in regard to her association with JIMMY FRATIANNO, SAL AMARENA, and other organized crime figures in the San Francisco area.

San Francisco intends to continue the current RICO investigation concerning FRATIANNO, AMARENA, and others, and is working in close coordination with other law enforcement agencies such as the San Francisco Police Department and the San Mateo County Sheriffs Office in this investigation.
