RE CHICAGO LETTER JULY EIGHTEEN LAST AND LEGAT, MADRID

LETTER JULY TWENTY SEVEN LAST ENTITLED RICHARD CAIN. (S)(u)

RECENT CONTACT WITH CG NINE FIVE SIX ONE-PC, CLOSE CONFIDANT
OF CAIN, ESTABLISHED THAT CAIN REPORTEDLY CONTINUES TO BE IN
MADRID, SPAIN AS OF MID-AUGUST. PC STATED HE HEARS THAT CAIN
MANAGES A SMALL CASINO AND HOUSE OF PROSTITUTION THERE. (u)

SOURCE ADVISED HE ALSO LEARNED THAT CAIN REPORTEDLY CONTINUES
IN CLOSE CONTACT WITH GIANCANA, FORMER TOP LEADER OF ORGANIZED
CRIME IN CHICAGO, WHO, ACCORDING TO SOURCE, CONTINUES TO RESIDE
IN MEXICO. (u)

SOURCE AGAIN ADVISED HIS INFO IS THAT CAIN'S PRIMARY ROLE IN
MADRID IS TO ESTABLISH CONTACTS WITH NARCOTICS DEALERS THERE AND
IN OTHER PARTS OF EUROPE AND TO ARRANGE FOR NARCOTICS SHIPMENTS (u)
