BRODKIN that his brother, "POPS" had become an alcoholic.

"PEANUTS" then complained concerning the way the "G has been throwing the heat on" in Chicago since his return from the State Penitentiary in Tennessee. He complained that times have changed in this regard in Chicago.

PANCZKO then advised that his nephew had become a dope addict and mentioned that he had called the "pusher" and in a very rough way instructed him to lay off selling the stuff to his nephew.

PANCZKO then discussed the fact that he had been brutally beaten by Warden GARFIELD (ph) at Ripley, State Pen, Tennessee, and that when his mister visited him, she could see the signs of his beating on him. She therefore returned to Chicago where apparently she contacted BRODKIN who instructed her to contact the FBI. PANCZKO then described how he was contacted and interviewed at Ripley by FBI agents who took a signed statement from him showing the violation of his civil rights. PANCZKO indicated that he was never thereafter again beaten.

The conversation then changed to an associate of TIPANCZKO, Chicago Top Jewel Thief, CART MENDOLA. BRODKIN commented that he feels that "MENDOLA is a pigeon for that lieutenant, ENGERS."

In speaking of "stool pigeons," BRODKIN mentioned that someone told him that <u>CARLYRIORITO</u>, former Chicago Top Jewel Thief, was a stool pigeon, but BRODKIN contended that this was not true, and that FIORITO was a real "stand up guy" and that BRODKIN would do anything for CARL.

In continuing this line of conversation, BRODKIN and PANCZKO then discussed one "CHESTER" who "was a real tough guy to get along with." This undoubtedly is a reference to former Chicago Top Jewel Thief CHESTER GRAY, who for some time was an informant of the Chicago Office.
