HARRIETTE BLAKE reportedly was to appear as a singer on the local television program of RAUL ASTOR. The records of Mexican Immigration indicate that she previously came to Mexico in September 1966 with a permit enabling her to appear on the television program of ASTOR, who has a well known local variety show.

The attorney acting for BLAKE in that matter was JORGE CASTILLO, Plaza de la Republica 32, the same attorney who has represented CAIN and GIANCANA with Mexican Immigration. At that time she furnished her address as Box 1066, Cuernavaca, Mexico, telephone 2 61 75. It was indicated that she had two children, JEANINE BLAKE, age 12, and LINDA BLAKE, age 5. Letters on her behalf were sent to Mexican Immigration by JAIME FERNANDEZ and MIGUEL GARCIA SOUTO of the Mexican National Association of Actors, Altamirano 126, Mexico City.

Sources noted that RAUL ASTOR, an Argentine, is reported to have heart trouble and to own and live in a luxurious home in Cuernavaca.

Attempts will be made to locate and determine adti-vities of CAIN because of his relationship with SAM GIANCANA. $\mathcal{G}(\mathcal{Y})$
