MAIL FRAUD

On July 31, 1951, complaints were filed and warrants were issued at El Paso, Texas, charging Pereira and Lee with Conspiracy, Interstate Transportation of Stolen Property and Mail Fraud. These complaints were based upon information furnished by Mrs. Gertrude Joyce Pereira, Roswell, New Mexico. She and her sister Kathryn Joiner came to El Paso, Texas, and stopped at the Del Norte Hotel. Lee and Pereira, staying at the same hotel, struck up an acquaintance with the women and returned to Roswell with them three days later as house guests. Lee posed as an oil lease operator and Pereira posed as a wealthy sportsman who had just been divorced and had the car stolen from a wealthy gentleman. A whirlwind courtship was conducted in Roswell, New Mexico, and they left for Quebec City, Canada, on Aug 24, 1951. Lee and Pereira returned to the U.S. with \$47,000 and a Cadillac automobile between the time of their meeting in April of this year and June 21, when they disappeared.

Information has been received that subjects Pereira and Lee are now staying at the Marion Richelieu Hotel, Quebec, Canada. Pereira and Lee are described as follows:
