VICTOR EMANUEL PEREIRA, FUG., JAMES BRADLEY LEE, FUG., MRS. GERTRUDE JOYCE PEREIRA, VICTIM, CONSPIRACY, ITSP, MAIL FRAUD. MORRIS STUODNA, KCMO, AUTO DEALER, ADVISED HE HAD RECEIVED INFORMATION FROM UNIDENTIFIED FRIENDS OF SUBJECTS THAT SUBJECTS ARE NOW STAYING AT MARION RICHELIEU HOTEL, QUEBEC, CANADA. EFFORTS BEING MADE TO IDENTIFY PERSON FURNISHING THIS INFO. TO STUODNA. IF LOCATED HE WILL BE INTERVIEWED. FOR INFO. OF ALBANY AUTHORIZED COMPLAINTS FILED JULY THIRTY LAST BY USC, EL PASO, CHARGING PEREIRA AND LEE WITH CONSPIRACY, ITSP AND MAIL FRAUD. COMPLAINTS BASED UPON INFORMATION FURNISHED BY MRS. GERTRUDE JOYCE PEREIRA, ROSWELL, N.M., ON APRIL NINETEEN LAST. GERTRUDE JOYCE, WEALTHY WIDOW, AGE FIFTYFIVE, AND SISTER, KATHRYN JOINER, AGE THIRTY, CAME TO EL PASO STOPPING AT FASHIONABLE DEL NORTE HOTEL. LEE AND PEREIRA STAYING AT SAME HOTEL, STRUCK UP ACQUAINTANCE AND RETURNED TO ROSWELL WITH WOMEN THREE DAYS LATER AS HOUSE GUESTS. LEE POSED AS OIL LEASE OPERATOR, PEREIRA POSED AS WEALTHY SPORTSMAN WHO HAD JUST BEEN DIVORCED AND HAD FORTYEIGHT THOUSAND DOLLARS COMING IN SHORT TIME FROM PROPERTY SETTLEMENT WHIRLWIND COURTSHIP CULMINATED IN MARRIAGE OF PEREIRA AND JOYCE IN KCMO, MAY TWENTYFIVE LAST.
