Transmitted herewith to the Bureau and each office receiving a copy of this letter is one photograph of THEODORE SANDERSON, JERRY SPERLING, and THEODORE CLARK. These photographs were obtained from the Identification Division of the Miami Beach Police Department and although no Miami Beach Police Department number or FBI number is known for these individuals, the New York City identification number appears on each photograph.

Sergeant PETE STEWART of the Detective Bureau of the Miami Beach Police Department has advised that he himself arrested PAUL AUGUSTUS KING, FBI #2594295, and FRED BROWN, FBI #4806462, at Miami Beach on March 19, 1947. Sergeant STEWART advised that KING, BROWN, JULIUS CARDO, TED CLARK, a Mr. and Mrs. TED SANDERSON and JERRY SPERLING were all associates at Miami Beach at that time and were operating with crooked dice and altered cards at Miami Beach during the 1947 season. According to Sergeant STEWART, PEGGY REILLY, a beauty shop operator at Miami Beach, Florida, and SANDERSON's wife acted as steers for this group. He advised that his original information relative to this group had come from PEGGY REILLY, also known as PEGGY SIMON and PEGGY KELLY, who had received a bad deal from KING. He had arrested KING and BROWN but had been able to only hold them temporarily inasmuch as PEGGY REILLY had not been able to prove a case against them and he had been unable to locate the other individuals associated with KING and BROWN. According to Sergeant STEWART, BROWN was subsequently dropped by KING and his associates and is believed presently to be in the Miami Beach area. However, Sergeant STEWART advised he had since been unable to re-locate BROWN and to his knowledge none of the other members of the group had been operating on Miami Beach since 1947. Sergeant STEWART advised that to his knowledge no one by the name of BRADING or JAMES LEE or VICTOR PEREIRA ever operated in the Miami area.

Investigation at Fort Lauderdale, Florida has reflected that Mrs. ELEANOR ROWE NICHOLS is presently Mrs. GEORGE McFEE and that she resides with her husband at Lake Worth, Florida where they operate the restaurant "Hobnob". Mrs. McFEE will be interviewed in the near future in detail.

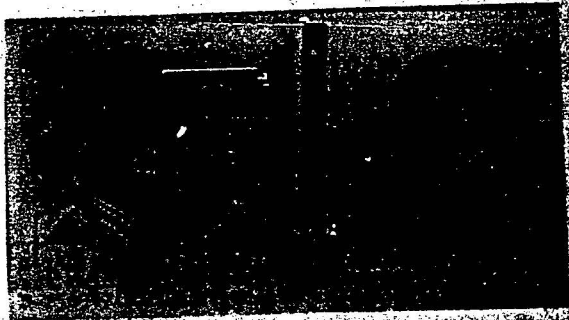
