The records of the Lodge reflect that the membership of DADB M. CLREY was transferred from Kansas City, Missouri, Lodge No. 98 to Denver Lodge No. 17 on .pril 4, 1950.

Mr. PITT stated that he is not personally acquainted with PEREIA, and could furnish no additional information concerning him. He stated that he is casually acquainted with Mr. G.REY but knows nothing-concerning has background in our manage activities.

By teletype dated September 25, 1951, the El Paso Office requested Denver to immediately interview CURTIS ROFFRT MAGNER concerning a telegram sent from Denver, Colorado, signed, "CURTIS" on april 24, 1951, to VICTOR E. PEREIRA, Roswell, New Maxico. It was also requested that an attempt be made to secure original of this telegram or name of appropriate person to be subpoenced to produce the same.

Mr. CURTIS ROBERT WAGNER voluntarily appeared at the Denver Office on September 26, 1951, at which time he was interviewed by Special Agent GEORGE F. GILLEM and the reporting agent. Mr. W.GNER stated that he is President of the Wagner Machine and Mill Supply Company, Inc., 4444 York Street, Denver, Colorado, and resides with

He emplained that the principal business of the vaguar scining and company, Inc., he to service and manufacture acquired conveyors and various parts and accessories used in grain mills. He stated that he has been engaged in this business since 1959. TAGNER stated that he has been engaged in this business since 1959. TAGNER stated that he was born karch 20, 1910, at Centertown, Missouri, that he resided in Manages City for a number of years and was a member of the Detective Ture u of the Fansas City Police Department from 1954 until 1935. He suched that he came to Denver in 1957 and has resided in Lenver since that time.

He related that approximately two or three years ago he was residing at an apartment at 1801 High Street, Denver, at which time he become acquainted with DADE I. CARE and his wife, "GOLDIS". He stated that the Careers were residing in the same apartment building and told him that they had formerly resided in Kansos City, Missouri. He sorted that COPEY appeared to have no regular business but always appeared to have plenty of money and he learned after a few months! acquaintance with CLEST that the latter was a professional gambler. He stated that in the Fall of 1949, he, in partnership with C EX, purchased a residence at 747 Newport Street, Denver, and that just before Christmas, 1949, he and his wife moved into that residence which they shared with D. N. CLAST and his wife. He stated that shortly thereafter CLASY, with his wife, made an extended trip to Lexico and after they returned to Denver two or three months later, the C:REYS started staging elaborate parties at the Newport Street address on which occasions, D. K. CIRKY was obviously gambling heavily with his guests. WiGHER stated that gambling activities continued at the Newport Street address to such an durant that he and his wife, who never engaged in gambling activities, tecame dissatisfied and moved out of the residence in December, 1950.

He stated that he continued to be on friendly relations with CLRIM and in the Spring of 1950, at which time he was attempting to produce a special air compressor at the hagner Machine and Hill supply Company, he borrowed approximately \$15,000.00 in cash from CLARM to extend operations on this compressor. He stated that CLARM was never actually an official of Lagner Machine and Hill Supply Company and was interested in the firm only to the extent of his investment on the air compressor. He related that this project eventually fell through, that CLARM now has no interest in the firm but that he still owes CLARM approximately \$2,000.00 on the original \$15,000.00 loan.

PEREIR. care to Denver in the Summer of 1950, at which time they visited with the CLREYS at 747 Newport Street, and apparently had been acquainted with the CLREYS for a number of years. He stated that this was the first time that he met the PEREIR.S and it was his understanding at that time, that they had been divorced some years ago but were frequently together. He stated that he understood that LD. PEREIR. cwas an interest in the Senator Hotel, Reno, Nevada, and that she spends considerable time in Kansas City, Missouri. He related that after meeting PEREIR., he observed that the latter was frequently in the company of KING and CLREY; that PEREIR. was a "good mixer" and apparently was used to the suckers" into crap games in which CLREY and KING participated. Fr. MIGNER stated that in about December, 1950, ADA PEREIR. purchased the St. Francis Hotel at 411 14th Street, Denver, Colorado, that she and VICTOR PEREIR. resided there but that VICTOR owned no interest in the hotel. He stated that to the best of his recollection, ADA sold the St. Francis Hotel during the latter part of February, 1951.

Mr. MIGN'R further related that one J. LLOTD GIBSON, of Melby, Colorado, who owns ranch interests in that area, has frequently associated with KING and CLPET and has apparently been used by them for the purpose of contacting wealthy ranchers who can be "taken" in cord and died games.

He stated that ROBERT EROUN GIBSON, son of J. LLOYD GIBSON, has, for some time, been closely associated with KING and CIRKY and apparently has recently been participating in gambling operations with them. He stated that he first met ROBERT EROUN GIBSON during the Fall of 1950 at which time he was introduced to GIBSON by CIRKY. He stated that shortly thereafter, he entered into a business agreement with GIBSON and took him into the Wagner Machine and Mill Supply Company as a member of the firm. He stated that GIBSON put up several thousand dollars but turned out to be a very undesirable business partner and was "maining the business" by gambling with the customers and "playing than for suckers". He stated that about six months ago, the situation

Lugher stated that VICTOR BELINULL PEREIRA, during the Fall and Winter of 1950, frequently associated with ROTERT BROWN GIBSON and occasionally was at the offices of the Wagner Machine and Hill Supell Company in Denver but was never at any time employed by that firm in any capacity. He stated that during January, 1951, PEREIRA was frequently with KING and CLREY and during the Stock Show held in Denver during the latter part of January, 1951, apparently was participating with KING and CLREY in dice games held in KING's suite at the Cosmopolitan Hotel in Denver. Mr. MICHER stated he is not acquainted with EUGENE PRINDEY, with alias J.MES BRIDLEY LEE.

He stated that after the Denver Stock Show, which ended during the latter part of January, 1951, KING and C.REY, with C.REY's wife, COIDIE, went down to Phoenix, rizona, and it was his understanding that PEREIRA also went to Phoenix at about the same time. He stated that he understands that PEREIR_ stayed at the Wostward Ho Hotel and that MALS and the CAREYS stayed at the Lidams Hotel in Phoenix. He stated that sometime in the Spring of 1951, possibly during the month of woril, KING and the CLREYS returned to Denver but he has not seen VICTO: PEREIRI. since the latter went to Phoenix during the latter pert of Conumy or the first part of February, 1951. Mr. MIGNER stated that he has had no communication of any kind from PERETAL since the latter left Denver and specifically stated that he has received no phone calls, tolegrams, or letters from PEREIRA. He related that ac first heard of the swindle of Mrs. OFFIRME J. WOYCE in which PEREIL was allegadly involved, in about May, 1951, when he received a telephone call from an attorney in El Paso, Texas, inquiring as to whether PEREIRA was or had been an employee of the wagner Machine and Mill Supply Company. He stated that on that accasion, he understood from this attorney, that PETELL had defrauded E.s. JOYCE out of a large sum of money and had beer using the address of Lagner Machine and Mill Supply Company, 4444 York Street, as his business address. He stated that he knows nothing concorming the details of this alleged swindle and specifically demied that he had over sent any telegram to PEREIR, at any time. He recalled that during the Spring of 1951, after D. M. CAREY had returned to Denver from Phoenix, that CLREY told him that he had had a falling out with PERSON and that the latter had "joined mother mob" in Phoenix. Mr. MAGNE: stated he had no more specific details concerning this incident.

ir. in CNER informed that he is willing to cooperate fully with this office in connection with this matter and voluntarily furnished a sample of his handprinting in the event it might be of use in connection with this investigation. We stated that in his opinion D. M. C.REY is the closest associate of PEREIR. in Denver, Colorado, and undoubtedly could furnish information concerning this case.

D.DY HURION CUREY voluntarily appeared at the Denver Office on the evening of September 26, 1951, and was interviewed by Special agent GECAGE F. GILLEN and the reporting agent. He stated that he is also known as D.DE H. C.HEY and "JUNE" CUREY, and resides with his wife, "COLDIE" at 747 Newport Street, Denver, Colorado, telephone number Florida COSS. He stated that he was born September 4, 1898, at Vibard, Missouri, and for a number of years operated a number of drug stores in Kansas City, Missouri, with his father, D. H. C.REY, Sh. He stated that in 1929 his father was connected with an arson ring in Kansas City, Missouri; that one of his drug stores was destroyed by fire during the course of which three Kansas City firemen were killed. He related that as a result of this incident both he and his fither were charged with murder and arson in Kansas City, Missouri, ut before the murder came to trial, his father committed suicide and the charges against him, D/DY H. C.REY, were subsequently dropped.

He stated that in 1915 he was arrested at the Biltmore Hotal, atlanta, Georgia, for gambling and fined 25.00, and that he was arrested several times on gambling charges in Kansas City, Hissouri, but that he has never been convicted of a felony.

CLREN informed that he is a gambler and has no other business connections. He stated specifically that he is "a dice man" and that he has operated with PLUL LUGUSTUS KING, commonly known as GUS LING, for a number of years in Denver, Colorado; Kansas City, Missouri; Phoenix, Lrizona; and in various resort areas around the country. He stated that in 1947 he invested several thousand dollars in the Lagner Machine and Mill Supply Company, Denver, Colorado, in connection with an air compressor that was being developed by CURTIS ROBERT LIGHLE, President of the company, but that he has never been an official of that company or actively engaged in the business. He stated that he has resided in Denver with his wife, "GCLDIE", since 1948 and prior to that time for several years operated the Highway Tavern, 5047 Van Brunt Lyemme, Mansas City, Missouri.

whose maiden name was alla RICE, for over twenty-five years, having first met her in Kansas City, Kissouri. He recalled that in approximately 1932 at Clathy, Kansas, she married one FRLINK H/RT, who was formerly a hotel manager in Chicago, Illinois, and during the probation era had been a "Chicago bootlegger". He stated they were divorced in about 1935. He stated that thereafter .D. married J. BOZEK'N, a professional billiard player who resided at Vallejo, California. This marriage ended in divorce and thereafter, according to C.REY, .D. married VICTOR PEREIK. (in about 1944). He stated that at that time she owned a part interest in the Senator Hotel, meno, Nevada, and still retains an interest in that establishment. C/REY stated that it is his understanding that sometime during the 1920's .D. was married to E.R. BREKER, a Kansas City, Hissouri, beetlegger, who, according to C.REY, now operates "Evergreen By the Lake", a restaurant and tavern located at Evergreen, Colorado.

CLREY stated that he first met VICTOR EMINUL PEREIR. when the latter came to Kanses City, Missouri, with M. sometime in 1944. He stated at that time PEREIR. claimed to be an "engineer" but he soon learned that PEREIR. was permiless and had the reputation of being a "check artist". He stated that he never heard of PEREIR. being convicted or arrested on bad check charges.

CEREY recalled that in 1945 he and his wife wint to keno, Newada, where they visited with VICTOR and LD. FERSIR. at which time LD. FERSIR. attempted to induce CEREY to invest some money in the Senator Hotel. He stated that he declined to do this.

CLREY stated that sometime in 1946, to the best of his recollection, DL divorced PEREIR, probably in Renc, Nevada, and thereafter she was married for a short time to a dentist, whose name CLREY stated, he could not recall. He stated that PEREIR subsequently married a Renc, Nevada, girl and that they now have a small child. He stated, however, that despite the subsequent marriage, DL and VICTOR PEREIR. have frequently associated with each other since their divorce.

He stated that in the Spring of 1950 PEREIR. came to Denver, Colorado, with some girl from Reno, Nevada and checked in at the Cosmopolitan Hotel. He stated PEREIR. was broke at the time and borrowed \$200.00 from him and thereafter remained in Denver for several months associating with GERRY LLEN and ERNIE 2. CODERD, both gamblers who had formerly resided in Kansas City, Missouri. CHEY stated that in the Fall of 1950 LL. PHEIR came to Denver and during the month of December, purchased the St. Francis Hotel. He stated that thereafter, for several months, VICTOR PEREIRA and ADA were practited and VICTOR from time to

CLREY described GIBSON as a close friend of his and stated that he has never heard of GIBSON being involved in any illegal activities, although he stated, that CIBSON occasionally participates with him in gambling activities in Denver.

C.REY stated that during the Stock Show held in Denver during January, 1981, PEREIRA was occasionally in the hotel suite of GUS KING at the Cosmopolitan Hotel and also present at the hotel during this period was "DOC" SOLOLAY and JANES ERADLEY LEE. CARRY described SCIOLAY and LEE as gamblers and con-men and explained that LEE's usual method of operation is to get acquainted with a wealthy woman, propose marriage and then defraud her of all the money that he could get out of her.

CLREY related that during the first part of February, 1951, he and his wife and GUS KING drove down to Phoemix, Arisona, and registered at the ideas Hotel. He stated that SOLOLAY and LES were at the hotel at that time. Shortly thereafter, he received a phone call from VICTOR PEPEIR! in Denver, Colorado, stating that he and ADA were going to keep. Nevada, via Phoemix and expected to spend a few days in Phoemix. He stated shortly thereafter, VICTOR and ADA PEREIR! are very in Phoemix and stayed at the home of JCE ILLULISON, whom KING described as a "slot machine operator" in Phoemix, Arisona.

He stated that during the latter part of February, ADA and hrs. ILLILIESON left by automobile for Reno and VICTOR PEREIRA and JLESS EXECUTE LEE then secured a suite at the Westward Ho Hotel and while .DA was away, then proceeded to entertain various women in Phoenix. He stated that when hrs. WILLIASON and ADA PEREIRA returned to Phoenix sometime during March, 1951, ADA and VIC had an argument over VIC's association with other women and subsequently "split up", ADA thereafter going to the home of the WILLLASONS where she remained for several days before returning to Denver to dispose of the St. Francis Hotel.

C.REY since 1949 and through C.REY, became acquainted with CURTIS ROBERT MIGNER of the agner Machine and Hill Supply Company, 4444 York Street, Denver, Colorado, during the latter part of 1949.

He stated that in about Merch, 1950, he bought controlling interest in the Magner Wichine and Mill Supply Company and sold out his interest in the firm to CURTIS R. WAGNER on December 28, 1950. He stated that in the Fall of 1950, he was introduced to VICTOR EMANUAL PEREITAL by D. H. CUREY and sometime previously had met ADA PEREIRA who is a long time friend of the CAREYS.

GIBSON stated that D. H. CARRY and GUS KING had, for a number of pears, been close friends and partners in private dice and card games in Denver and in various resort areas around the country and that he has been acquainted with KING for approximately two years as a result of his association with CARRY. He stated that during the Stock Show season in January, 1951, in Denver, Colorado, he became acquainted with DCC SCLOUNT and JUINS ERUDISM IRE while they were staying at the Cosmopolitan Rotel in Denver. He stated that as he recalls, he was introduced to them by VICTOR PERSIRA.

In connection with his supposition with the above named individuals, GIBSG related that he has, during the last year, on several occasions participated in private dice and card games with GARRY and has observed that GUS KING is apparently the "front man" and "steerer" to get businessmen into the games and that he, GIBSON, has personally acted in this capacity on several occasions. He stated that PERETIAL, whilein Lenver, was present at a number of games in KING's suite at the Cosmopolitan Hotel, and apparently is a good friend of GARRY and KING. GIBSON stated that he is not well acquainted with JIMES BRADLEY LEE and has not seen him since January, 1951.

GIBSON specifically denied that he had ever discussed with FMEDPA the latter's plans to defraud krs. NCYCZ and claims that he had no knowledge that LEE and FMEDPA were operating such a swindle. He admitted, however, that sometime in April, 1951, he received a long distance telephone call from FMEDPA at which time the latter discussed with him the sale of certain fishing reels on which FMEDPA claimed to have a patent. He stated that he was in Denwer at the time he received this call but does not know where FMEDPA was located at the time he placed the call. He denied that there was any discussion of the swindle at that time.

Es stated that during the latter part of April, 1951, exact date immedalled, he received a special delivery letter from VIDIOR PRESERVA which was addressed to him at his home in Denwer, Colorado. He stated that he does not recall the return address on this latter more the postmark nor does he recall that the letter mentioned anything about PRESERVA having plans to narry a wealthy woman. He stated that he recalls that there was a telegram enclosed in the letter addressed to PRESERVA in care of someone else but he claims not to recall the name of this person nor the address shown on the telegram. He claims that to the best of his recollection, it was addressed Turson or Phoenix, Arioma. He claims that he does not recall any telegram addressed to Roswell, New Mexico. He stated that the letter requested him to send the telegram and that there were three or four one dollar bills enclosed to pay the charges.

GIBSON stated specifically that the telegram mentioned above was either written or handprinted in pencil, that it was addressed to VICTOR B. PINEIDA and that it specifically mentioned that PINEIDA had received a divorce in Denver and as a part of the divorce settlement was to receive a large amount of money. GIBSON claimed not to recall the exact amount of money mentioned and claimed to recall no other specific details concerning the message. He stated that he does recall that the message was signed, "CURTIS".

GIBSCN stated that on the morning that he received this letter at his residence, he read it and also read the telegram and thereafter on the same day, while he was driving in an automobile with D. H. CAREY, he showed the letter and the telegram to CAREY; that CAREY read the letter and telegram, and handed them back to him, making no communt as to whether or not GIBSCN should send the message as requested by PEPERMA. OIBSCN stated he recalls that CAREY told him to "just forget you showed the letter to ne". He stated that after exhibiting the letter to CLREY he tore the letter up and threw it out of the automobile and placed the telegram in his pocket.

GIBSON stated that on that same day or the following day, at about 11 A.M. he drove to the eatgrn Union Office at 17th and Champs

Streets in Denver, and when he could not find a parking place, he handed the telegram with three one dollar bills to a man who was leaning against a parking meter directly in front of the Western Union Office and requested him to send the message. He claims that he does not know this man's name and has never seen him since that time and does not know whether or not the man actually sent the message, although he assumes that he did so.

GIRSON declined to furnish any more specific information, stating that the above account of the incident is all that he can remember and declined to furnish a signed statement.

Information concerning this telegram as furnished by CUREN and CURSCH was submitted to the EL Paso Office by teletype dated September 27, 1981.

By teletype dated September 29, 1951, the El Paso Office stated that the United States intorney there does not contemplate prosecutive action against SIESSN unless the latter proves refractory in testifying in this case.

It was requested that GIBSON be reinterviewed in an effort to obtain a detailed signed statement from him and that he be specifically questioned as to where the letter from PEREIFA was mailed and exact date of receipt of same by him. It was further requested that GIBSON be reinterviewed concerning alleged dostruction of the letter and to attempt to determine whether he possibly still has the letter in his possession. This teletype also requested that the name of individuals competent to testify that no divorce action was pending in Denver for PEREIFA in April, 1961, be furnished to El Paso.

In accordance with the above request, GIBSCN was reinterviewed October 1, 1981, by Special Agent KEMMETH K. R.UPLCH and the reporting agent. At that time he reiterated the account previously furnished by him concerning the telegram and reiterated his previous contention that the letter from PERERA requesting that he send the telegram had been destroyed. He contended that he could not recall the exact date he received the letter from PERERA nor could be recall from what point FERERA had mailed the letter. He stated that he had no recollection of the postmark or return address. He stated that he did not desire to give a signed statement but was willing to testify in this case and if he did testify, his testimony would be the same as he had furnished orally to Agents on September 26, 1951.
