LAST, WAS DECIDED THAT SYLVESTER WOULD TAKE THIRTY FIVE THOUSAND DOLLARS
RETURN NYC, THEN PROCEED TO EL PASO, TEX., WHERE HE WOULD ATTEMPT TO
DISTRIBUTE THIS MONEY TO QUOTE DISTRICT ATTORNEY ENQUOTE AND OTHERS WHO
