The confidential source referred to in attached LMS is NY 3936-C, whose identity is known to the Bureau. This information was furnished to SA O. EUGENE SMITH on 2/6/64.

Source advised that he would find out the amount of the loan that SAM WAGER is attempting to obtain and also the date that the commitment was sent out to him and Midland Hospital.

JOHN KIELLY, referred to in attached LHM, is a real estate broker in the office of NY 3936-C.

The source advised that he is handling the legal matters of all the loans referred to in attached LMMs and that he is receiving legal fees for work performed by him in this matter which are legitimate fees. He advised that he is not accepting any payments of "green" or any other illegal fees pertaining to these loans. The fees that he is receiving are strictly legitimate and will be recorded in his books and records.

Source advised that he is of the opinion that he will have advance notice of actions taken by any parties involved in these loans and will keep the NYO advised of current developments.

It is noted that a \$7500 check that KIELLY received from BROWN was cashed by KIELLY in BROWN's bank in Dallas, Texas. KIELLY gave the \$7500 to NY 3936-C for safe keeping. NY 3936-C has placed this money in his personal safety deposit box. He advised that this money is to be distributed as "green" when the loan is obtained by BROWN. Source advised that he is not to receive any of the \$7500 himself.

If the Bureau opens separate cases on these loans NY will do likewise and sufficient copies of attached LHMs have been made in the event that its deemed advisable to disseminate information appearing therein to other FBI offices.
