On 1/2/69, NY 6436-C-TE advised he has learned that SALVATORE GRANELLO, father of murder victim MIKE GRANELLO, is greatly upset and angered over the killing of his son.

According to informant, GRANELLO will check with his "skipper" (LCN "boss") in attempt to learn if LCN ordered this action or if it was result of some unidentified persons acting on their own. If latter, GRANELLO reportedly will determine their identities and take retributive action upon his release from FCI, Danbury. GRANELLO is tentatively scheduled for release in about sixty days.

Through NY 3446-C-TE, the NYO has learned of several recent actions on the part of MIKE GRANELLO, any of which could have resulted in his murder. Included in this, is the reported "contract" to "hit" GRANELLO, which arose from a "sitdown" of lower East Side hoodlums in October, 1968.

Accordingly, NY is making arrangements to have SALVATORE GRANELLO contacted by Special Agents at FCI, Danbury, in order to elicit any information he may wish to furnish concerning LCN participation in his son's killing.

Attempt will be made to contact GRANELLO on 1/9/69,
