An information copy of this report is being designated for New York file 156-126, captioned, "MID-CITY DEVELOPMENT CORP.; SALVATORE GRANELLO aka - FUGITIVE; WPPDA", since GRANELLO is carried as a subject and a fugitive in this case.

In view of the fact that GRANELLO is in a fugitive status in this substantive case, fugitive is carried in the title of the Anti-Racketeering report.

Investigative leads to locate GRANELLO are not being set out in this report as they are being handled in the Mid-City Development Corp. case. The NYO is coordinating the AR investigation with the WPPDA investigation and therefore, the results of other investigation thus far conducted to locate the fugitive is not being set forth in this report.

NY T-10 advised that GRANELLO was in the Boston area, but that his exact whereabouts were unknown. NY T-10 stated that GRANELLO intends to surrender himself to New York authorities after the Labor Day weekend because he has the situation "bagged" and will make bail immediately. NY T-10 stated that he last saw GRANELLO at the Surf Dinner Club, Revere, Mass., on the evening of 8/3/69 when subject indicated that he was desirous of obtaining a passport for Venezuela.
