NY 4103-C-TE advised SA WILLIAM DAVID KANE
on 9/8/65 that he is currently engaged in a dredging
operation in Key West, Florida, which operation is
being conducted in connection with the building of
a marina. During the previous two weeks, the
informant discovered that the ~~Coin Meter Company~~,
Miami, Florida, had quietly purchased 38 acres of
prime beach front property owned by the City of
Key West, for the purpose of building a marina.
This property was leased to the company under a 99

year lease and the agreement was to pay the City a five percent rate of the yearly net income. Informant advised that one JERRY CONLEY, President of Coin Meter Company, which company services juke boxes and automatic laundry machines, is an ex-convict from Chicago, Illinois recently released from jail and that his partner in the company is SALVATORE GRANELLO aka Sally Burns. *JLL*

In discussion with CONLEY, informant was told to contact GRANELLO in NY to complete negotiations for the dredging of the proposed marina site. Informant learned that CONLEY had bribed a highly placed Key West City official to lease the above-mentioned property. *JLA*

On 10/8/65, informant advised that he had been in telephonic contact with CONLEY who told him that he visited JAMES RIDDLE HOFFA approximately 10 days ago in Las Vegas and that HOFFA agreed to try to arrange for the Teamsters Union to loan the Coin Meter Company one million dollars.

Informant advised that Coin Meter Company is presently near bankruptcy and is being sued by the Walter Heller Company in Miami. CONLEY advised that he had withdrawn himself from the Coin Meter Company so that no ex-convicts would be listed as officers and that he was attempting to have the Walter Heller Company withdraw the suit until the Teamster loan comes through. *JLA*
