ADMINISTRATIVE:

Based on information furnished by NY 4336-C-TE to the effect that SALVATORE GRANELLO has never forgiven THOMAS EBOLI for authorizing the "hit" on GRANELLO's son, MICHAEL, in 1968, who was reputedly dealing in narcotics, GRANELLO has been opened as a PC of this office. GRANELLO has been openly stating that EBOLI should have shown him the respect of at least consulting him prior to authorizing the "hit".

The NYO anticipates interviewing GRANELLO to determine his potential as a C-TE. The Bureau has been advised that any interview with GRANELLO should not jeopardize the pending WPPDA cases under which GRANELLO is a subject. The AUSA in the SDNY who is handling these cases has been contacted and stated he has no objection to GRANELLO being contacted along theelines as long as the interview is limited and does not concern the pending substantive violations.

NY T-2 referred to in the details of this report is SEYMOUR SISKIND who has been contacted by Buagents and who is under development as an informant. He has displayed a cooperative attitude and it is felt that he is in an excellent position to furnish information regarding GRANELLO's activities.

Information copies of this report are being designated for MM and SJ in view of their interest in this case and since additional investigation might be requested in those Divisions.
