On 11/12/63, NY 3936-C advised that EDDIE LANZIERI, JOE/RIZUTTO, and SALLY CELEMBRINO, were anxious to open a bingo game in Brentwood, Long Island. Informant stated that these individuals had met with a MRS. LEONI (PH) whose husband is a member of the Brentwood Town Council. Informant was told that MRS. LEONI is connected with the CARLO GAMBINO "family".

Informant further advised that an individual, named JOE BIONDI, advised him to stay away from GEORGE LEVINE and SALLY BURNS, because LEVINE is a "creep" and SALLY BURNS is nothing anymore. BIONDI also told informant if she tisdin trouble with either LEVINE or BURNS, to call EDDIE LANZIERI or himself and they will straighten it out.

The above information is not being set out in the details of the report, inasmuch as this informant is an extremely sensitive source and routine reporting or investigation concerning any of this information would undoubtedly endanger this informant since he was in attendance at the above meeting.

On March 13, 1964, HARRY H. ERDMAN, Chief Special Investigations, INS, advised that subject, LANZIERI is the subject of a contemplated investigation by their office.
