ADMINISTRATIVE: (CONT'D)

A photograph of the subject was directed to the Bureau in New York letter to Bureau dated 10/7/63 under caption "Criminal Intelligence Program - Hoodlum-Album".

During the period of this report contact was maintained with the Federal Bureau of Narcotics, 90 Church Street, NYC. It was learned that the subject, arrested in 1961, is presently out on bond. Proceedings in this matter have not commenced since that agency is attempting to locate two fugitives named in the same indictment with the subject. It was generally understood that prosecution in this matter involving GUIGA would commence in the near future. Agents of the Federal Bureau of Narcotics indicated that they had a "good" case on the subject and his co-defendants and that their interest concerning the subject while out on bail is continuing.

In view of the Federal Bureau of Narcotics pending prosecution of the subject as well as that agency's continuing interest in his activities while on bail, additional investigative effort might tend to jeopardize their case. Consequently this matter is being placed in a pending inactive status, in order that the prosecutive status of this case may be followed and reported.
