SUBJECT DEPARTED WITH GIRLFRIEND FOR FLORIDA DURING THE PAST WEEK. INFORMANT STATED SUBJECT IS A CLOSE FRIEND OF BELLE BARTH, NOTED RECORDING STAR OF RISQUE SONGS AND JOKES, AND MAKES HIS "HEADQUARTERS" AT THE CLUB WHICH SHE IS FEATURED OR OWNS IN THE MIAMI AREA. *2*

MIAMI WILL ENDEAVOR TO DETERMINE IDENTITY OF THE ABOVE CLUB AND IF FREQUENTED BY THE SUBJECT. THEREAFTER DETERMINE RESIDENCE OF THE SUBJECT IN THE MIAMI AREA AND AFFORD CONSIDERATION OF HIGHLY CONFIDENTIAL SOURCE COVERAGE ON HIS ACTIVITIES. MIAMI WILL IMMEDIATELY ADVISE THE BUREAU AND NEW YORK RE RESULTS OF ABOVE INVESTIGATION. *11*
