SALVATORE GRANELLO AKA, AR. [Anti-racketeering]

ON JUNE 11 LAST, JUSTICE OF PEACE WILLIAM ARMSTRONG, GREENWOOD LAKE, NEW YORK, ADVISED SPECIAL AGENT JOHN J. MC MANUS THAT COMPLAINT HAD BEEN RECEIVED RE SUBJECT FROM PARENTS OF ONE JANIE WILLIAMS, AGE 15. WILLIAMS WAS ALLEGEDLY RAPED BY SUBJECT.

NEW YORK STATE POLICE INVESTIGATOR GERARD STROMMER, MONROE BARRACKS, ADVISED THAT SUBJECT ACQUAINTED WITH WILLIAMS APPROXIMATELY FIVE YEARS AND LATTER IS AN ASSOCIATE OF SUBJECT'S CHILDREN.

WILLIAMS SUFFERS FROM NERVE INJURY IN HER BACK AND CURRENTLY UNDER MEDICAL TREATMENT. GRANELLO HAS DISCUSSED WITH WILLIAMS AND HER PARENTS THE POSSIBILITY OF CONSULTING A NYC SPECIALIST RE HER PHYSICAL CONDITION. HE HAS ALSO DISCUSSED THE POSSIBILITY OF HAVING HER EMPLOYED AS A MODEL.

ON JUNE 10 LAST, GRANELLO CALLED WILLIAMS AND REQUESTED HER TO MEET HIM AT HIS SUMMER RESIDENCE. HE STATED HE WISHED TO DISCUSS TENTATIVE APPOINTMENTS WITH THE SPECIALIST AND A MODEL AGENCY. WILLIAMS ALLEGEDLY APPEARED AT THE SUBJECT'S RESIDENCE IN HER BATHING SUIT AT A TIME WHEN THE SUBJECT WAS ALONE. SHE POSED IN THE BATHING SUIT AND IN THE NUDE FOR PICTURES TAKEN BY GRANELLO WITH WILLIAMS' CAMERA. GRANELLO REMOVED THE FILM AND

MAINTAINED POSSESSION OF SAME. THEREAFTER, GRANELLO ALLEGEDLY HAD INTERCOURSE WITH HER. WILLIAMS ADVISED INVESTIGATING OFFICERS THAT SHE WAS TOO FRIGHTENED TO PROTEST AT THE TIME, BUT LATER ADVISED HER BOYFRIEND, THOMAS ZANDER, OF THE OCCURRENCE.

GRANELLO TOLD WILLIAMS THAT HE WOULD TAKE HER TO CONSULT THE SPECIALIST IN NYC ON JUNE 11 LAST. HOWEVER, IN THE EVENT HIS CHAUFFEUR WAS UNABLE TO PICK HER UP HE GAVE HER \$20 FOR BUS FARE TO NYC.

FOLLOWING DISCLOSURE OF THE ALLEGED RAPE BY WILLIAMS TO ZANDER, THE LATTER SUGGESTED THAT SHE ADVISE HER PARENTS AND THEREAFTER, WILLIAMS' MOTHER ADVISED THE NYS POLICE. WILLIAMS WAS EXAMINED ON THE EVENING OF JUNE 11 LAST BY DOCTOR (FNU) ROBBINS, GREENWOOD LAKE, NEW YORK, WHO ACKNOWLEDGED THAT WILLIAMS HAD SEXUAL RELATIONS BUT WAS UNABLE TO DETERMINE THE TIME OR PREVIOUS CHASTITY OF WILLIAMS DUE TO THE LAPSE OF TIME SINCE THE OCCURRENCE.

INVESTIGATOR STROMMER ADVISED THAT HE WAS TAKING A DETAILED STATEMENT FROM WILLIAMS AND HE ANTICIPATED FILING AN INFORMATION AGAINST GRANELLO CHARGING STATUTORY RAPE. STROMMER ACKNOWLEDGED THAT HE HAD NOT RECEIVED ANY CORROBORATING EVIDENCE TO DATE BUT HOPED TO LOCATE GRANELLO AT HIS RESIDENCE IN GREENWOOD LAKE, NEW YORK, AND CONDUCT SEARCH WHICH MIGHT REVEAL THE PHOTOGRAPHS OR OTHER PHYSICAL EVIDENCE OF THE CRIME.

IN THE EVENT GRANELLO IS NOT LOCATED AT GREENWOOD LAKE,
