It has been alleged that an individual named De Joie, the former Prime Minister of Haiti, is leading a revoluntionary group from the Dominican Republic in an attempt to overthrow the government of Haiti.

Salvatore Granello, a member of the New York criminal element, has indicated a desire to establish gambling casinos in Haiti. It has been alleged that when De Joie requested \$20,000 in cash immediately to purchase arms and food, Granello and James Plumeri, who is also interested in establishing gambling in Haiti, backed off temporarily since they did not want to lay out this amount of cash.
