Each proposal will be followed closely with the source. When information of a more positive nature is developed as to specific identification of principals involved as well as the details of any payoffs, a new case will be opened under the appropriate caption and the Bureau advised immediately along with NY's recommendations as to whether above investigation can proceed without compromising source.
