On 1/25/62, NY 1894-PC, who has furnished reliable information in the past, advised SA WARREN J. DONOVAN that he had just returned from a few days visit in Miami Beach, Florida. He stated while there, he was with his partner, FRANK DIOGUARDI, where they operate the Dream Bar, Miami Beach. On 1/23/62, he said he was invited to Sonny's Restaurant, 23rd St., off Collins Ave., Miami Beach, Florida, by DIOGUARDI, who said he had a meeting there. The informant said that when they arrived, he, the informant, went to the bar and the following individuals were seen with DIOGUARDI:

FLH
NICK MASCHUOCI aka Nick Garry, from NJ; SALVATORE GRANELLO aka Sally Burns; JOSEPH INDELICATO aka Joe Scooch; JAMES NAPOLI aka Jimmy Nap; THOMAS MUSCHITTI (phonetic), possibly the owner of Sonny's Restaurant. The informant did not know what this meeting was in relation to.

Miami has been requested to ascertain the purpose of this meeting.

NY 1894-PC, mentioned above, is an individual who possesses a criminal record, is acquainted with many underworld figures in NYC area and who has been involved in theft and fencing of stolen goods.
