SUBJECT: AMERICAN GAMBLING ACTIVITIES IN CUBA

General Investigative Intelligence File

PCI TIRSO SACERIO advised on January 12, 1957, that NORMAN ROTHMAN, former operator of the Sans Souci Night Club in Havana, Cuba, is presently living in Camaguey, Cuba. Source stated that ROTHMAN received the gambling concession at the Copacabana Night Club in Camaguey and that the casino was opened and put into operation on December 31, 1956.

Source stated that ROTHMAN received help and political influence from TONY PEREZ BENITO, who is married to the daughter of President BATISTA of Cuba. Source advised that PEREZ BENITO is supposed to have a half interest in the gambling casino and that ROTHMAN is acting as manager.

Source stated that ROTHMAN also allegedly has slot machines in various bars and night clubs in other cities in Camaguey Province. Source stated that arrangements for installation of the slot machines were made through the influence of PEREZ BENITO and ALBERT ARDURA. ARDURA is alleged to be one of the principal backers of slot machines in Cuba and is known to have considerable interests in gambling operations in the Havana area.

Source was also contacted with reference to fugitive cases pending in the Havana Office and he advised that he has not received any information concerning any of the individuals wanted by the Bureau with reference to whom he had been previously contacted.
