The Ohio Bell Telephone Company records reflect telephone number WASHINGTON 1-2173 is listed to FRANK ROSEN, 12805 Shaker Boulevard, Suite 508, Cleveland, Ohio.

184. The Cleveland Retail Credit Men's Company, on June 10, 1958, listed ROSEN's wife as SOPHIA, that his credit rating from 1928 - 1950 was poor; that he was formerly manager of the Rapid Smoke Shop at 2045 East 105th Street, Cleveland. The Cleveland "Press" of August 30, 1945, reported information concerning FRANK ROSEN's connection with the "281 Club" in the Hotel Hollenden, this place being described as a gambling spot.

Lieutenant MARTIN COONEY, Cleveland Police Department, in 1944 described FRANK ROSEN as the Manager, Hollenden Bridge Club, which is a notorious meeting place for members and individuals closely associated with the gambling element.

MOE DALITZ was interviewed by Bureau Agents on June 25, 1945, at which time he stated he maintained a financial interest with four other partners in the operation of Suite 281, Hollenden Hotel, managed by FRANK ROSEN. This was reported as a gambling operation.

In July, 1946, the then Cleveland Informant CL-118, advised that FRANK ROSEN, who managed the gambling headquarters of the Cleveland gambling syndicate located in Suites 281-2-3-4, Hollenden Hotel, which was discontinued sometime ago, is now assigned to the Beverly Hills Country Club gambling casino operated at Ft. Thomas, Kentucky, by the Cleveland gambling syndicate.

OHIO Mr. ROBERT JOYCE, Manager, Hollenden Hotel (use T-symbol), on July 3, 1958, advised that FRANK ROSEN did have a gambling spot in the Hotel years ago. He said ROSEN also ran a "chemin de fer" game for MORRIS KLEINMAN, LOU ROTHKOPF, and MOE DALITZ, but fell into disfavor with these men because of mismanagement of the spot. JOYCE said ROSEN went into "booking" for himself and may still be doing this although he has been a pretty sick man for a number of months. Mr. JOYCE said that ALLARD ROSEN, Floor Manager of the Desert Inn, Las Vegas, Nevada, is the son of FRANK ROSEN and probably secured this position through his father's contacts. OHIO
