PCI LOUIS SACCAROMA, Miami, was interviewed by SA ELMER F. EMRICH on October 8, 1958, at which time he advised he had just returned from Havana, Cuba, several days ago. He indicated his wife's parents operate a large printing firm in Havana, Cuba.

According to this informant, he visited most of the gambling casinos while there, as a result of which he furnished the following information:

(1) Sans Souci Casino

Informant who is acquainted with SANTOS TRAFFICANTE, JR., stated while he did not see TRAFFICANTE in the casino he learned through an employee he would be there later in the evening.

(2) Hotel Havana-Riviera Casino

He advised he observed both DUSTY PETERS and DINO (LNU) (undoubtedly referring to DINO CELLINIO) at this casino, and learned they were in charge of its operations.

(3) Hotel Nacional Casino

While at this casino informant conversed with JAKE LANSKY, and he was advised that MEYER LANSKY was in Hollywood, Florida, receiving treatment for a bad case of
