When BIEBER informed PRIO concerning the above situation, PRIO opined that the police may have "surrounded" this meeting due to the recent bombings of restaurants in the Chicago area. This caused PRIO to comment, "All these guys need money, their businesses are going bad, so they set their places on fire." This caused BIEBER to comment, "And you guys get the blame for it." This may be a significant comment, indicating that organized crime in Chicago is not involved in the wide-spread arson and bombings which have taken place in Chicago during the past two years. On the other hand, PRIO may have made this comment to BIEBER for strategic purposes.

At this point, BIEBER attempted to learn the location of BRODKIN and was informed by BRODKIN's secretary that she was informed by BRODKIN that he would be "on the boat." PRIO then commented that the secretary must refer to the yacht of Chicago top hoodlum FRANK FERRARO.

BIEBER and PRIO then discussed which restaurant the Chicago hoodlums were discovered in. BIEBER did not appear to be certain of the name but felt that it was either the Cork Restaurant on Dempster Avenue in Skokie, Illinois, a northern suburb of Chicago, or the Cart Restaurant on Wabash. During this discussion, PRIO mentioned that the Cork Restaurant in Skokie is the "joint where DAVY goes" and BIEBER commented that he had observed DAVY there the previous night. This is an obvious reference to Chicago and Miami top hoodlum DAVY YARAS It is noted that information has previously been obtained from CG 6614-C indicating that the Cork Restaurant in Skokie is a favorite hangout of North Side hoodlums.

While PRIO waited for the return of ALDERISIO and SOLANO, he discussed politics with BIEBER. It became obvious during this conversation that PRIO favors the election of President JOHNSON over Senator GOLDWATER.

PRIO then "requested BIEBER to recontact"HY" and "find out what's going on."
