Belet reports that you have recently initiated investigation of the subject in connection with the Criminal Intelligence Program, and requested authority to conduct a survey to determine feasibility of misur coverage in the office of Max Lurie, 19 West Flagler, Miami. Lurie is identified as an attorney who is closely associated with the subject.

It is not deemed advisable to conduct such a survey at this time since you have not submitted sufficient information indicating Lurie is engaged in organized criminal activity. You are reminded that the Bureau does not desire misur coverage of attorneys in the absence of extraordinary circumstances which call for this type coverage.

The investigation of Yaras should be vigorously pursued and a comprehensive report promptly submitted concerning his background and criminal activities.

NOTE: Miami has opened a new AR case on the subject, who is a Chicago hoodlum currently residing in Florida. Miami requests authority to survey office of subject's attorney to determine feasibility of misur coverage. It is recommended this not be approved since Miami has not submitted sufficient justification for such action.
