Sources report that DAVID YARAS departed Miami, Florida, area for Chicago in 7/64 and returned to Miami approximately 9/1/64. YARAS observed at Bay Shore Country Club, Miami Beach, 9/2/64. Information developed and set out concerning the Klene Linen Supply Co., Miami Beach. The linen supply portion of this company sold to Cascade Linen Supply, Miami, 3/64, for sum of \$85,642.64. BEN HUSICK, alleged business partner and associate of YARAS interviewed and denied interest of YARAS in Klene Linen Supply. Information relating to income tax returns of YARAS from 1955-1962 reported herein.

DETAILS

I. PERSONAL HISTORY AND BACKGROUND

Marital Status

MM T-14 advised on July 21, 1964, that it is her understanding that YARAS has remarried fairly recently and that his new wife is named PAT. It is noted that YARAS' wife of many years is named MARILYN PAT YARAS. However, this informant insists that YARAS' present wife has been with him only a little more than a year.

This document contains neither recommendations nor conclusions of the FBI. It is the property of the FBI and is loaned to your agency; it and its contents are not to be distributed outside your agency.

The records of the Miami Beach Police Department do not reflect an arrest of YARAS since February 4, 1959.

ARTHUR H. LEONARD, JR. (NA), Chief of Detectives, Miami Beach Police Department, advised SA HILL this date that he has not heard of any recent information regarding YARAS, that he believes YARAS is "retired" and has not seen him more than once or twice per year, those occasions being at the Bay Shore Country Club, Miami Beach. Chief LEONARD states that it is his belief that YARAS is a partner of LEONARD PATRICK in gambling in Chicago, but does not know of any activity on the part of YARAS in Miami Beach.

Regarding BEN HUSICK, Chief LEONARD states that he has learned that HUSICK recently underwent two heart attacks and has been more or less inactive lately. He said that, like YARAS, he knows of no activity on the part of HUSICK linking YARAS with him.

MM T-3 on August 7, 1964, advised that DAVID YARAS earned the following annual incomes from the years 1955-1962:
