PCI advised on 4/20/67 that DAVID YARAS has only been observed twice at the apartment in the last three months and the last time was approximately one and a half months ago.

OTHER 4

RONALD YARAS, the other son of DAVID YARAS, is now operating Unique Import Trading, Ltd., at 1644 North Honore, Chicago. This was formerly operated under the name of M&E Sales Company and at one time was run by MANNY GREENFIELD.

OTHER 4

On 4/21/67, PCI advised that DAVID YARAS has not been seen for a couple of months in Chicago and only occasionally comes here. The informant stated again that to his knowledge DAVID YARAS has no direct connection with Unique Import and that the operation is handled by RONALD YARAS.

On 3/23/67, BEN KAPLAN, 6521 North Sacramento, Chicago, advised he has worked at M&E Sales for ten years and now works for RONALD YARAS at Unique Import. KAPLAN said DAVID YARAS has no voice in the company and it is run on a legitimate basis. He said DAVID YARAS visits at the business occasionally, but has not been seen for some time.

On 4/21/67, KAPLAN said he has not seen DAVID YARAS in Chicago for several months.

OTHER 4

On 4/20/67, PCI Credit Manager of the Continental Plaza Hotel, 909 North Michigan Avenue, Chicago, advised SA CARLTON H. WOLFARTH that DAVID YARAS does not reside at the hotel and has no apartment leased. The informant checked his records and showed a photo of YARAS to his security force with negative results.

Chicago in its coverage has been unable to determine the exact whereabouts of YARAS outside of the Chicago area and has presumed he is in the Miami area when not in Chicago.

Chicago has no objection to be designated office of origin in this investigation, but at the present time, Chicago cannot assure more coverage than is already maintained due to YARAS' infrequent visits to Chicago. There appears to be no indication that YARAS will be in the Chicago area on a more frequent basis than he has been in the past.
