Chicago Office advised on 1/26/70 that their indices disclosed that according to records of the Chicago Police Department JULES JAFFE, 601 West Washington Street, and 3415 Elaine Place, both Chicago, was charged along with six others for Receiving Stolen Property. This case was nolleprossed in Felony Court.

Chicago also advised that according to their file 87-10192 JULES JAFFE along with others were subjects of an ITSP case which investigation disclosed that JULES SAFJAFFE, 47, of 708 Buena Avenue, Chicago, was arrested by the FBI on 12/16/57 and was found to be in possession of 9 watches taken in the captioned case. These watches were valued at \$6,325. The case against JAFFE was dismissed.
