On 2/27/63, JOHN KOUN, Special Agent in Charge,  
Region VII, 111th INTC Group, Miami, made available a  
report concerning JORGE ALONSO PRYOR, dated 2/15/63.

JORGE ALONSO PUJOL BERMUDEZ has been a long-time  
acquaintance of SA JAMES D. HAYES, and has expressed a  
desire to assist the U. S. Government whenever possible.  
From time to time he has furnished information which has  
come to his attention in which he believed the FBI had an  
interest. He has advised he will continue to do so, should  
any such information come to his attention.

In view of the fact that he is no longer engaged  
in any Cuban political revolutionary activities, he is  
not under consideration at the present time for development  
as a PSI.

In connection with the case concerning PABLO HIPOLITO ORGANVIDES, he has advised he was ready and available to testify in any U. S. Court if so called upon. He also has been of assistance to the U.S. Army in the Recruitment Program of members of Cuban Brigade 2506 into the U.S. Army.

In view of the foregoing information, it is not believed any additional investigation is warranted, and this case is being closed.

With reference to Bureau letter 5/16/63 concerning JORGE ALONSO PRYOR, it is noted that in the enclosed LHM information furnished by the Department of Defense is set out which was received laterally from the U. S. Army, Miami.
