activities in Mexico and with regard to his connections with anti-CASTRO groups in the Miami area. Later on the same date ROJAS telephonically contacted the Miami Office and stated that he would appear at the office in a few minutes and wished to make a clean breast of everything relating to his recent trip to Mexico.

During the course of interview ROJAS appeared to be emotionally unstable and somewhat unbalanced. He was very cooperative and readily furnished all requested data, seemingly to the best of his ability, but gave the impression of being somewhat unnerved by his recent experiences.
