FELDMAN and his three associates in Feldman Enterprises, Incorporated, sold their captial stock in that company in June, 1961 for \$242,296.

LEONARD FELDMAN is at this time President and a director of WNXT, Incorporated, an Ohio corporation which has an office at 360 North Michigan Avenue, Chicago, but operated Radio Station WNXT in Portsmouth, Ohio. A financial statement for that company as of May 31, 1961, indicated a net worth of approximately \$78,000 and a good current position, although noncurrent liabilities were ineexcess of net worth.

BEN SHORR and LEONARD FLEDMAN appear as Vice-President and Director, respectively, of G.M. Vending Corporation, distributors of automatic vending machines. That is an Illinois corporation chartered April 5, 1962, with a reported paid-in capital of \$10,000. The company originally operated at 2441 West Peterson Avenue, but has discontinued at that address, and now, maintains only a mailing address and telephone answering service at 2414 West Lawrence Avenue, from which orders are forwarded to 2937 West Peterson. Financial and other details concerning that enterprise have declined.

CGT:29 further advised that according to available information an involuntary bankruptcy was filed against the Hilton Rug Company, Incorporated in United States District Court at Chicago, Illinois, on June 1, 1962.
