This report is classified SECRET because it contains information obtained from sources reflecting investigative interest in a foreign diplomatic establishment, disclosure of which would be prejudicial to Bureau work. (S)(U)

By separate letter the Bureau is being requested to have the Legal Attache, Havana, advise the identity of the resident of Calle O #48, Vedado, Havana, the address given by subject when he flew on Cubana Airlines to Havana on July 6, 1960; also, any information concerning the nature of Universal S.A., Humbolt #106, telephone 70-7100, in Havana.

By separate letter the Atlanta Office is being requested to determine if the Atlanta Office of Western Union, a relay center, may possess a copy of a telegram directed to GENTRY at Miami, assuming it originated outside the United States, for the dates June 14 or 15, 1960.

Record of the checking account of MARY B. GENTRY at the Hialeah-Miami Springs Bank, Hialeah, Florida, was made available on July 11, 1960, by Vice President WOODROW W. ASBURY to SA JAMES J. O'CONNOR.

Translation of the letter of the Cuban Air Force, dated October 22, 1959, attesting to subject's position with the Cuban Air Force, was performed by Translator ELEANOR SCHOENBERGER, Miami Office.
