Results of interview of EDWARD HANNON as contained in this report were received in New Orleans airtel to the Bureau, October 25, 1960, entitled "JIM HOUGH; ET AL; ECONOMIC MATTERS - CUBA", MM 110-5-40.

MICHEL YABOR and MARCOS DIAZ LANZ, whose interviews are set forth in this report, advised that REINALDO BLANCO, former Cuban Air Force Paymaster, who would have knowledge of payments made to GENTRY, was recently in Miami, but has returned to Cuba in connection with underground activity against the CASTRO government.

Sources who furnished information concerning the 26th of July Club of Miami were AL TARABOCHIA, Dade County Department of Public Safety; AL CANTA, INS, Miami. Defected members of 26th of July Club who were contacted were ALCIDES GONZALEZ GONZALEZ, former President, and RANULFO SIERRA Y FERNANDEZ, former Treasurer. The confidential source mentioned in the characterization is PSI, (Under Development).
