On July 24, 1963, a confidential informant, who has furnished reliable information in the past, advised that he had learned that one Ricardo Ferrera had contacted Julio C. Alegria Minister-Counselor, Embassy of Nicaragua and told Alegria that he had contacted Rafael Inclan, President of captioned organization. Inclan had heard that Ferrera had met with Luis Somoza, former president of Nicaragua and indicated to Ferrera that he wanted to be put in direct contact with Somoza. Ferrera told Inclan he could not put him in contact with Somoza, fout speaking of Alegria, told Inclan he would speak to a friend to see if the (5) friend would agree to meet Inclan to discuss his desire to see Somoza. Ferrera additionally told Inclan that his friend could send Inclan's request to Somoza in writing.

INTERNAL SECURITY - CUBA

Inclan's desire to meet Somoza stems from the fact that he represents an "action group which goes to Cuba many times." Ferrera noted that the group has a boat and cannons and wishes to send such equipment to Cuba.

Alegria was noncommittal regarding the above and indicated that he wished to discuss it further with Ferrera at another time.

The position of Julio C Alegria was verified through the Diplomatic List dated May, \$1963, published by the United States Department of States

The informant has previously received information indicating that Ferreragenad previous contacts with Alegria and (S) indicated he was associated with a firm he called Washington Investment Research and on another occasion gave his address as care of Robert A. Willgoos, 1025 Connecticut Avenue, N. W. The Washington, D. C. Metropolitan area Telephone Directory lists Robert A. Willgoos as an Architect.
