DETAILS: AT DALLAS, TEXAS

HELEN HERRY, advised that she is the owner and operator of the Beachcomber Bar, 1023 Main Street, Dallas, Texas, and HERRY further stated that the victim has been employed by her at the Beachcomber Bar as a waitress for the past eight or nine months. HERRY advised the victim came to the United States as a War Bride and during the summer of 1953 was divorced from her husband and the victim applied for a job at the Beachcomber Bar during the early part of 1954. HERRY advised that the victim has been residing with her at her residence at 4014 Va Boulevard, Dallas, Texas and during the time the victim was residing with HERRY, she was dating subject MONROE and HERRY is of the opinion that she was having sexual relations with MONROE. HERRY states that during the early part of September 1954, the victim told her that MONROE had asked her to accompany him on a trip to El Paso, Texas and further stated that an individual named TOMMY TAYLOR and his girl friend
