It is noted that FERRARO referred to SAVARESE as GEORGIE, however, GEORGIE is in all probability a common nickname used by FERRARO in his relationship with SAVARESE. SAVARESE's reference to VITO is unknown; however, the possibility exists that this may be VITO GENOVESE, New York top hoodlum.

### DOMINIC "HUNK" GALIANO

Information pertaining to GALIANO is furnished elsewhere in this report under Las Vegas Gambling Interests section. GALIANO who, until recently, was relatively unknown in crime syndicate circles is, according to CG 6272-C, a rising hoodlum on Chicago's north side who may possibly be replacing in stature JIMMY ALLEGRETTI and JOSEPH DI VARCO.

### FRANK "SKID" CARUSO

CARUSO is an old-time, well-known Syndicate gambling representative of Chicago's south side. CG 6343-C\* advised on April 5, 1960, that FRANK FERRARO and CARUSO had a short meeting during which the following was discussed:

CARUSO:

Hello FRANKIE. I just come in to drop something. The first District. They beat the (obscene) out of him.

FERRARO:

For what.

CARUSO:

Nothing. He was at the Brass Rail.
