DETAILS:

WALTER ZYBROSKI, superintendent, 201 West 108th Street, New York City, advised on December 15, 1953, that he had no list of tenants at this address in 1944, and he did not particularly recall any of them. He stated that a majority of the tenants had moved out and he noted that there were a great number of roomers living with most of the tenants during that period. (S) (u)

Mr. ZYBROSKI stated that he did recall the STALINSKY family, inasmuch as Mrs. STALINSKY still resides at this address. He said that Mr. STALINSKY had died about three months ago. Mrs. STALINSKY presently has several roomers, all of whom appear to be reputable people. He advised that one of them is a woman whose son is a doctor on Park Avenue. Mr. ZYBROSKI stated he had a vague recollection that a man by the name of DALLIN had lived at this address and that he had been contacted by agents of the Federal Bureau of Investigation in that matter, but he could recall no details. (S) (u)
