Attached is a copy of a name check request dated 7/9/68 which was received from [MI-5]. In the event this (S) information is subsequently incorporated in material prepared for dissemination, [MI-5 should be described as a (S) confidential source abroad.] Classify [MI-5] data "Confidential." (S)

On the basis of information furnished no definitely identifiable information concerning the subject was located in Bufiles. However, subject may be identical with the Adela de la Campa who is mentioned on page three of the enclosure to MMlet dated 9/20/65 captioned "Movimiento Democrata Cristiano (MDC), IS - Cuba, NM." This same communication indicates that Laureano Batista Falla is an official of the MDC. In fact, Bufiles contain voluminous information concerning this individual originating with your office. You are requested to determine whether Laureano Fernando Batista y Falla, mentioned in the attachment, is, in fact, identical with the individual of the similar name who is active in MDC affairs.

Review your files concerning the subject and submit any pertinent information concerning her in memorandum form suitable for dissemination. If her husband is identical with the individual who has been active in MDC affairs, incorporate in the memorandum a succinct summary of pertinent information concerning him with particular emphasis on the nature and extent of his involvement in anti-Castro affairs.

Since the Bureau contemplates disseminating the memorandum being prepared by your office [to MI-5] any information included therein originating with another Government agency must be cleared with that agency prior to its incorporation in the material prepared for dissemination. Where this is done an appropriate notation should be made in the cover communication accompanying the material prepared for dissemination.
