Subjects are husband and wife who reside in Florida. They have made visa application to visit the Bahamas. Laureano Batista has long been involved in anti-Castro activities and the information we furnished was a detailed account of such involvement. The information dealing with the incident as well as previous data which is of interest to MI-5 was discussed with Coast Guard and Customs in Miami which provided much of the data and they saw no reason why it could not be used by MI-5 or Bahamian Police for interview with subjects.
