Reurairtel 10/14/68 with enclosure. Enclosure contained information concerning an incident which took place in 1/64 in which the British frigate H.M.S. Londonderry was reportedly involved. You indicated that Coast Guard and Customs in Miami as well as your office knew of no reason why the data in the enclosure could not be used by MI-5 or Bahamian Police for interview with captioned subjects.

In view of the paucity of information concerning this incident set forth in the enclosure you are requested to advise whether MI-5 can utilize the information contained in the enclosure to your 8/5/68 letter as well as the information in the enclosure to the referenced communication to warn the subject and his wife that their involvement in anti-Castro activities is known to the authorities and that they must not engage in such activities while they are in the Bahamas. Since your 8/5/68 communication indicated that some of the information contained in the enclosure thereto originated with Customs, you should check with Customs and Coast Guard to determine whether the information provided by them to date in the captioned matter can be utilized to warn the subjects as proposed by MI-5.

NOTE: Subjects are husband and wife who reside in Florida. They have made visa application to visit the Bahamas. Laureano Batista has long been involved in anti-Castro activities and we furnished a detailed account of such activities to MI-5. There are indications the subject's wife has also been involved but to a lesser degree.
