23. CHARLES RUBEN ~~LAWRENCE~~, wa. Charlie Ruben ~~Lawrence~~,
FBI No. 4085623, Dallas PD No. 23965.

This individual is considered by CT-DL-26 to be one of the local "break-in artists" here for items such as cigarettes, and other items of this type. Sheriff DECKER of Dallas County states he has had this individual under suspicion for some time in local burglary cases.

24. ROY ROLAND ~~PARTIN~~, was, Roy ~~Roland~~, Roy ~~Hines~~, Roland Roy
Hines, FBI No. 1367751, Dallas PD #19704.

This individual is an associate of CHARLES RUBEN LAWRENCE and is considered by local Police Department and Sheriff's Office to be principally a "break-in artist" and small-time safe burglar.

25. THOMAS J. ~~SCHWARTZ~~, wa. Tommy, Tom Jack ~~Schwartz~~, FBI No.
2885839, Dallas PD #6729.

SCHWARTZ has been in the past considered by the Dallas Police Department and Sheriff DECKER of the Dallas County Sheriff's Office, to be the principal fence of stolen goods in this area; however, SCHWARTZ is at the present time under indictment for his past activities in connection with a local armed robbery, and has been given two trials in which both trials have resulted in a dead-lock because of a hung jury.

26. DEWEY ~~MORAN~~, was, Joseph Dewey ~~Moran~~, Joe ~~Morane~~, FBI No.
968345, Dallas PD #2058.

MORAN is considered by Sheriff DECKER of the Dallas County Sheriff's Office as a local small-time safe burglar and an addict of narcotics.

27. ALBERT ~~MEADOWS~~, FBI No. 856929, Dallas PD # 11974

According to Captain LUMPKIN of the Dallas Police Department, MEADOWS has been picked up by that department several times recently in connection with local criminal under-world, and is considered by them to be a small-time safe burglar.

28. HERBERT B. ~~NOBLE~~, FBI No. 1509123, Dallas PD # 9905

NOBLE in the past has been connected in various gambling activities, consisting of policy operations on a very extensive scale; however, it is the opinion of Chief of Police HANSSON and J. E. DECKER, Sheriff, Dallas County, Texas, that NOBLE is not involved in any degree of gambling at the present time, but it is their opinion that when local law enforcement in this area changes, that NOBLE will again enter the policy field.
