On 12/3 and 12/6/65, the 1958 white over blue Chevrolet bearing 1965 Texas license plates KJM 853, which the subject is known to drive, was observed parked in the rear of the apartment house in Farmers Branch, Texas, where the subject is known to be operating as a bodmaker. On 12/6/65, MEADOWS, BILLY RAY GRIMES and EDWARD DRISCOLL appeared in USDC, NDT, Dallas, and were arraigned on an indictment which was previously returned by a FGJ in Dallas, Texas. All three subjects entered a plea of not guilty and the Judge set the trial date for the three individuals for 4/4/65.

Investigation determined that MEADOWS has moved from his former residence at 948 Abrams Road, Richardson, Texas, to an apartment located at 11412 North Park Central Place. Both automobiles registered to MEADOWS have been observed parked in front of the residence on North Park Central Place.
